Annual Listing of Federally Obligated Projects



Purpose of this Report

Federal Laws, under Moving Ahead for the Progress in the 21st Century (MAP-21), requires that the Capital Region Metropolitan Organization, hereafter referred as "CRMPO", to publish a listing of projects using federal funds obligated annually.

The Federal metropolitan planning statute states:

“An annual listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which Federal funds have been obligated in the preceding year shall be published or otherwise made available by the cooperative effort of the State, transit operator and metropolitan planning organization for public review. The listing shall be consistent with the categories identified in the TIP.”

The annual listing provides a record of project delivery for the previous federal fiscal year. This report will list all transportation projects authorized between October 1, 2014 and September 30, 2015. The listing is also intended to increase the awareness of government spending on transportation projects to the public. Obligations of federal funds means that a project has received federal commitment for reimbursement, and does not necessarily mean that the project was initiated or completed in that year or indicate the total cost of that project.

Background

Capital Regional Planning Commission is the Metropolitan Planning Organization (MPO) for the Baton Rouge urbanized area. Every metropolitan area with a population of more than 50,000 persons has a designated MPO in order to qualify for federal highway and transit funding. CRPC, acting in its capacity as the MPO, has responsibility for planning, programming, and coordinating federal-aid transportation investments within the Baton Rouge urbanized area. As the MPO, CRPC

is statutorily mandated to assess the transportation needs and deficiencies of the region with direction from public officials, citizens, modal representatives and federal, state and local planning departments. In its capacity as the CRMPO, the CRPC utilizes two committees: the Transportation Policy Committee and the Technical Advisory Committee, which consists of officials from Ascension, East Baton Rouge, Livingston and West Baton Rouge Parishes. Figure 1, illustrates a map of the boundaries for the CRMPO.

The Transportation Policy Committee (TPC) provides policy guidance for the development, coordination, and implementation of the multi-modal transportation plan for the area and its supporting documents. The TPC is made up of local elected officials and representatives from relevant government agencies.

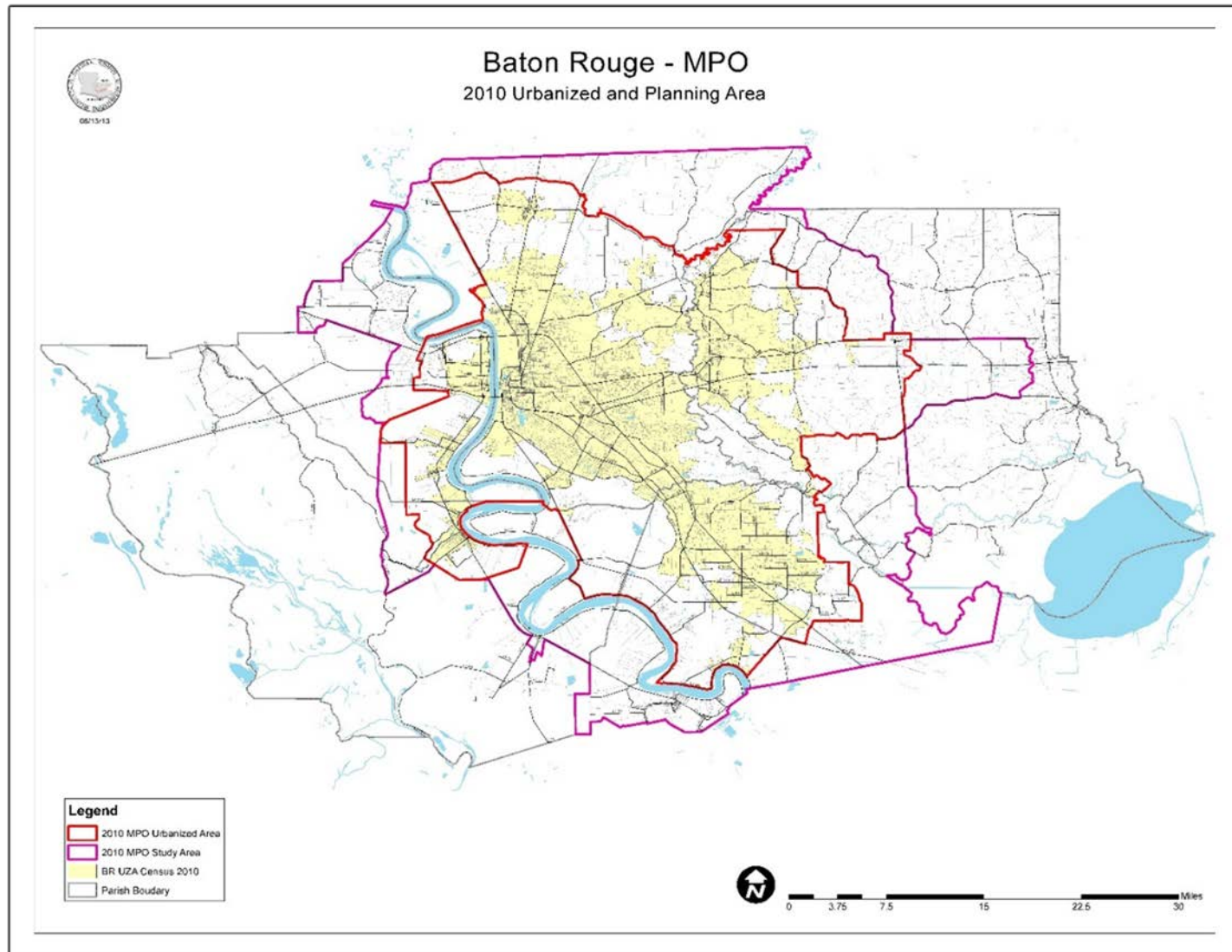


Figure 1. Capital Region MPO Urbanized Planning Area

Obligation Report

This report is organized by project phase for highway/bridge projects and funding category for transit projects. The Project ID, project name, description, funding source and the total obligation amount are shown for each project. The Project ID is a unique number given to each project selected for inclusion into the CRMPO's TIP and listing of Federally Obligated Projects. A brief description of each project is provided. The obligation is the federal share for that particular TIP project in the federal fiscal year. The obligation amounts for each of the projects are added up to show the total obligation by project phase.

While federal funding is included in this report, no local or state funds are reported. During FY2015, federal funding was distributed through the following funding categories:

- **Congestion Mitigation and Air Quality Improvement Program (CMAQ)** funding for projects that demonstrate the three following factors: transportation identity, emissions reduction, and location in or benefitting a nonattainment or maintenance area.
- **DEMO** Demonstration funding is a combination of different programs and sources. The FHWA administers discretionary programs through various offices representing special funding categories. An appropriation bill provides money to a discretionary program, through special congressionally directed appropriations or through legislative acts, such as the American Recovery and Reinvestment Act of 2009 (ARRA).
- **Highway Bridge Program (HBP)** funds use to the rehabilitation and replacement of structurally deficient bridge decks.
- **Highway Safety Improvement Program (HSIP)** The goal of the program is to achieve a significant reduction in traffic fatalities and serious injuries on all public roads, including non-State-owned public roads and roads on tribal lands. The HSIP requires a data-driven, strategic approach to improving highway safety on all public roads that focuses on performance.

- **National Scenic Byways Programs** Funds may be used to undertake eligible projects along All-American Roads, National Scenic Byways, State scenic byways and Indian tribe scenic byways and for the planning, design, and development of State scenic byways programs. Eligible projects include: making safety improvements to a highway designated as a scenic byway; construction of facilities along such a highway for use of pedestrians and bicyclists, such as rest area turnouts, overlooks, and interpretive facilities; improvements to the highway to improve access to recreational purposes; protecting historical and cultural resources along the highway; tourist information and scenic byways marketing plans and programs.
- **Federal Surface Transportation Program (STP)** This funding may be used for safety infrastructure improvements during preliminary engineering, design, and construction.
- **Federal Bridge On-System (FBR ON) and Federal Bridge Off-System (FBR OFF)** are federal funds used for the replacement, rehabilitation or widening of any federal aid facility on-system or off-system, respectively.
- **National Highway Performance Program (NHPP)** provides support for the condition and performance of the National Highway System (NHS), for the construction of new facilities on the NHS, and to ensure that investments of Federal-aid funds in highway construction are directed to support progress toward the achievement of performance targets established in a State's asset management plan for the NHS.
- **Railway – Highway Grade Crossing Program** This program provides funds for the elimination of hazards at railway-highway crossings.
- **Surface Transportation Program (STP >200k)** is used within the metropolitan area to fund roadway reconstruction, rehabilitation, traffic operational improvements, bicycle and pedestrian facilities, and studies.

- **Surface Transportation Program (STP Flex)** is a flexible funding category that is typically used by LaDOTD to fund roadway reconstruction, Intelligent Transportation System (ITS) projects, or bridge or interchange work.
- **Surface Transportation Program (STP HAZ)** funding is used to correct or eliminate hazardous conditions, improve traffic safety, and replace and upgrade traffic signal equipment.
- **Surface Transportation Program (STP ENH)** transportation-related activities that are designed to strengthen the cultural, aesthetic, and environmental aspects of the Nation's intermodal transportation system. The transportation enhancements program provides for the implementation of a variety of non-traditional projects, with examples ranging from the restoration of historic transportation facilities, to bike and pedestrian facilities, to landscaping and scenic beautification, and to the mitigation of water pollution from highway runoff.
- **State Cash – General Fund (ST CASH)** are budgeted from the state's general fund to be used at the discretion of the legislature.
- **Transportation Alternative Program (TAP)** provides funding for programs and projects defined as transportation alternatives, including on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation; recreational trail program projects; safe routes to school projects; and projects for planning, designing, or constructing boulevards and other roadways largely in the right-of-way of former Interstate System routes or other divided highways.
- **Transportation, Community, and System Preservation Program (TCSP)** This program provides funding for a comprehensive initiative including planning grants, implementation grants, and research to investigate and address the relationships among transportation, community, and system preservation plans and practices and identify private sector-based initiatives to improve those relationships.

- **FTA Section 5307** funds are used for capital, operating assistance, preventive maintenance and planning purposes for mass transportation improvements in urbanized areas.
- **FTA Section 5317 New Freedom** grants fund projects that create or enhance public transportation services and remove barriers for the disabled. New Freedom projects must be new (i.e., non-operational and/or unfunded prior to 2005) and must exceed the current requirements of the Americans with Disabilities Act of 1990. Activities funded by New Freedom must derive from the regional Coordinated Human Services Transportation Plan.
- **Job Access and Reverse Commute Grants (JARC Funding)** was established to address the unique transportation challenges faced by welfare recipients and low-income persons seeking to obtain and maintain employment. Many new entry-level jobs are located in suburban areas, and low-income individuals have difficulty accessing these jobs from their inner city, urban, or rural neighborhoods
- **FTA Section 5339** Provides capital funding to replace, rehabilitate and purchase buses and related equipment and to construct bus-related facilities.

Some projects include a mixture of different federal funding categories, and thus one project line under one funding source does not necessarily equal the total obligated funding for that project. The table below is based on records obtained from LaDOTD, FHWA, CATS and FTA, as CRMPO does not directly participate in the obligation prices

Summary of Federally Obligated Projects

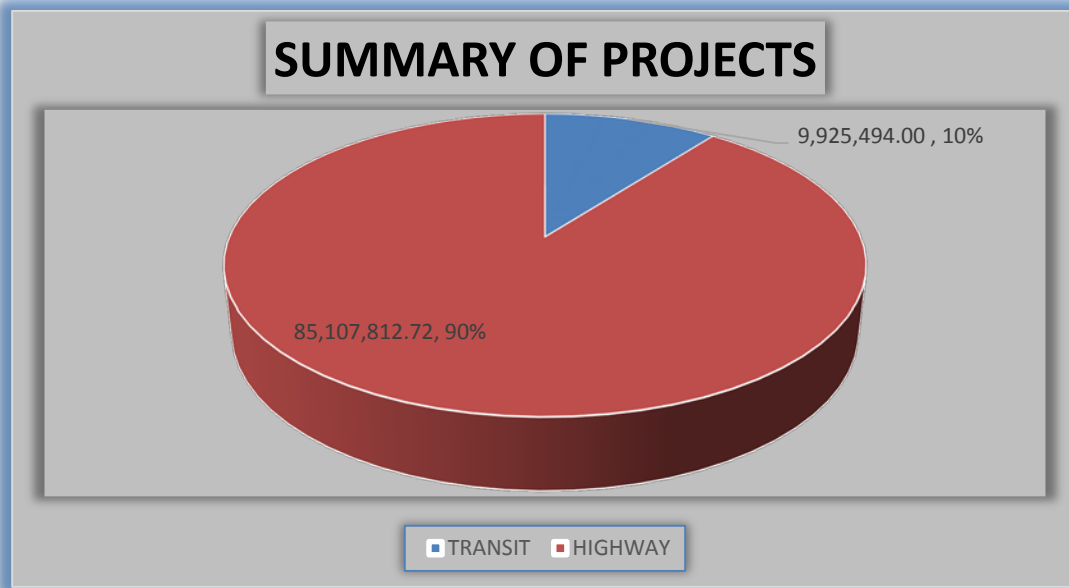


Figure 2. FY 2015 Federally Obligated Projects Summary

A total of \$80.39 million was obligated in FY 2015 for 80 transportation projects. Of this, \$85.11 million was for highway/bridge projects and \$9.93 million for transit projects. Highway Projects accounted for 90 percent of funds with transit accounted for the remaining 10 percent. Figure 2 below illustrates the distribution of funds between transit and highway projects:

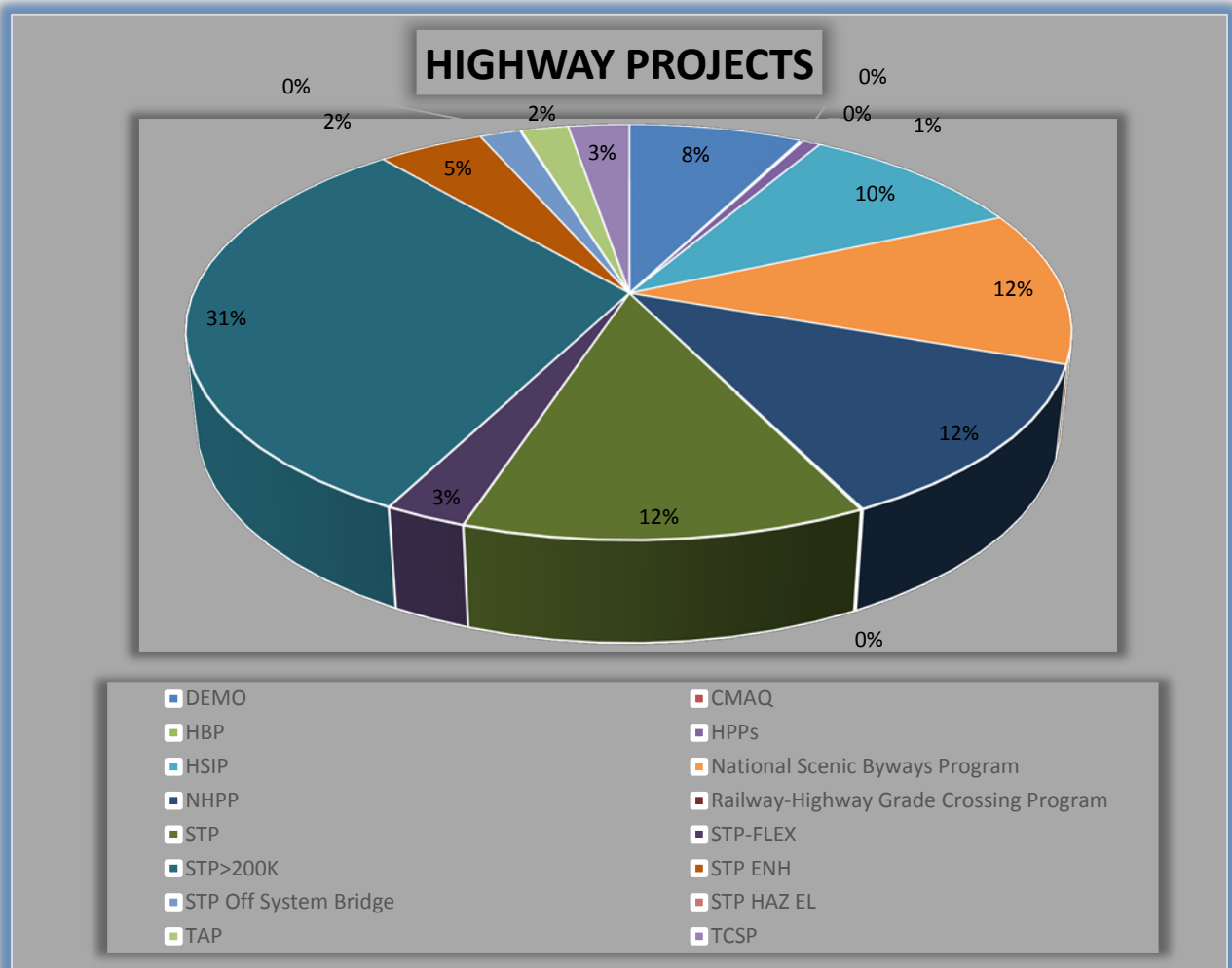


Figure 3. FY 2015 Federally Obligated Highway/Bridge Projects by Funding Category

Figure 3 shows the distribution of funds between various funding sources for the highways projects with the largest percentage of highway/bridge funds (31% total) obligated to STP>200K funding. These funds are used within the metropolitan area to fund roadway reconstruction, rehabilitation, traffic operational improvements, bicycle and pedestrian facilities, and studies.

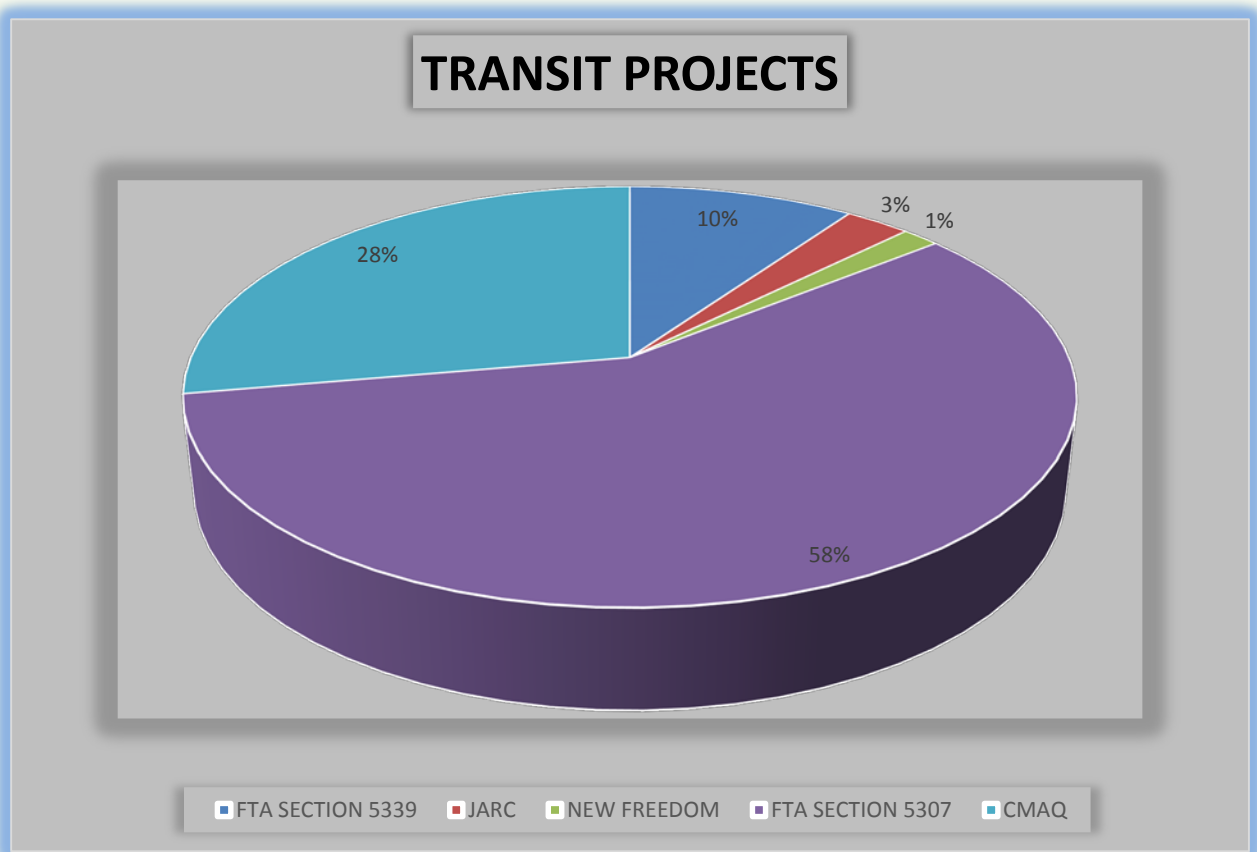


Figure 4. FY 2015 Federally Obligated Transit Projects by FTA Funding Category
