

D) CRPC Activity Update

- Safe Streets and Roads for All Grant (SS4A): Local Match Agreements + Next Steps
 - On February 1, 2023, CRPC was awarded \$480,000 for developing A Regional Safety Action Plan. The Local Match is \$120,000 (split among the 5-Parishes based on population. Total funds for Action Plan is \$600,000
 - Staff have relayed Local Match Agreements to all five Parishes to avail the local match.
 (WBR has signed, while rest four Parishes, agreement is awaiting approval)
 - CRPC worked with FHWA-LA Division in finalizing the SS4A agreement. (Agreement signed on June 2023) Staff anticipates developing the Action Plan in consultation with all local entities by June 30, 2024.
 - The Action Plan will help leverage all entities within the 5-Parish region to apply for Implementation grants for projects identified within the Action Plan.
 - Staff developed Scope of Work and issued RFP on June 9, 2023, and received two proposals at the end of deadline (June 30, 2023)
 - CSAP Selection Committee reviewed and scored the two proposals and issued the contract to Neel Schaffer Inc. on August 1, 2023.
 - CRPC Staff completed the first round of public engagement in the month of December 2023. The second round of public engagement was completed in February 2024.

 Currently, staff and consultants are conducting Stakeholder Interviews with local jurisdictions. We have completed interviews with: City of Central, Livingston Parish, City of Baker, Downtown Development District, CATS etc. We anticipate conducting interviews with EBR next.

• Pavement and Asset Data Collection (PADC) (IBR Parish Fugro Analytics)

- Staff has developed initial analytics from the Fugro pavement and asset data for IBR Parish. The next steps include holding a Parish leadership meeting to showcase the analysis.
- Staff have contracted with Fugro to provide cloud services for the data/video logs for member entity access. (Approval from LADOTD -Planning Division)

Climate Pollution Reduction Grant

- o Staff applied for CPRG for the Baton Rouge MSA on May 31, 2023.
- Staff received a request for additional information from EPA Region VI on July 19, 2023.
 Staff responded on July 27, 2023.
- Staff received further documentation and information from EPA Region VI on August 15, 2023, and responded on August 21, 2023.
- CPRG Grant Timeline: Augst 1, 2023 through July 31, 2027. (4 years) for total grant amount of \$1M.
- Key grant deliverables:
 - Priority Climate Action Plan (PCAP) Due March 2, 2024
 - Comprehensive Climate Action Plan (CCAP) due 2 years from grant award (summerfall 2025)
 - Status Report due 4 years from award (summer 2027)
- Staff issued an RFP for CPRG Action Plan on December 18, 2023 and received two proposals. The CPRG RFP Selection Committee reviewed and selected Sustainability Solutions Group USA Inc. & Co as the preferred consultant on January 19, 2023. A kickoff meeting was held with SSG on Tuesday January 23, 2024.
- Staff sent formal email notification to finalize CPRG Action Plan Review Committee on January 24, 2024.
- Staff submitted Baton Rouge MSA's CPRG QAPP on January 26, 2024 and submitted PCAP on March 1, 2024. We received confirmation that both the QAPP and PCAP were approved by EPA.
- Logo/branding is complete (April 2024).
- Next Steps: Initiate work on CCAP. Conduct Pre-engagement interviews with identified stakeholders and finalize engagement interviews from selected list.

Carbon Reduction Program (CRP)

- o Bipartisan Infrastructure Law (BIL) established CRP to provide funds for projects designed to reduce transportation emissions (COx) from on-road highway sources.
- BR MPO will receive ~\$1.9M apportionment every year starting FY 2022. Currently, CRPC has \$3.91M immediately available for funding projects.
- o Eligible Projects:
 - a project described in 23 U.S.C. 149(b)(4) to establish or operate a traffic monitoring, management, and control facility or program, including advanced truck stop electrification systems.
 - a public transportation project eligible under 23 U.S.C. 142.
 - a transportation alternative (as defined under the Moving Ahead for Progress under the 21st Century Act [23 U.S.C. 101(a)(29), as in effect on July 5, 2012]), including, but not limited to, the construction, planning, and design of on-road and off-road trail facilities for pedestrians, bicyclists, and other nonmotorized forms of transportation.
 - a project described in 23 U.S.C. 503(c)(4)(E) for advanced transportation and congestion management technologies.
 - deployment of infrastructure-based intelligent transportation systems capital improvements and the installation of vehicle-to-infrastructure communications equipment.
 - a project to replace street lighting and traffic control devices with energy-efficient alternatives.
 - development of a carbon reduction strategy developed by a State per requirements in 23 U.S.C. 175(d).
 - a project or strategy designed to support congestion pricing, shifting transportation demand to nonpeak hours or other transportation modes, increasing vehicle occupancy rates, or otherwise reducing demand for roads, including electronic toll collection, and travel demand management strategies and programs.
 - efforts to reduce the environmental and community impacts of freight movement.
 - a project that supports deployment of alternative fuel vehicles, including
 - o acquisition, installation, or operation of publicly accessible electric vehicle charging infrastructure or hydrogen, natural gas, or propane vehicle fueling infrastructure; and
 - o purchase or lease of zero-emission construction equipment and vehicles, including the acquisition, construction, or leasing of required supporting facilities.
 - a project described in 23 U.S.C. 149(b)(8) for a diesel engine retrofit.
 - certain types of projects to improve traffic flow that are eligible under the CMAQ program, and that do not involve construction of new capacity; [§ 11403; 23 U.S.C. 149(b)(5); and 175(c)(1)(L)]
 - a project that reduces transportation emissions at port facilities, including through the advancement of port electrification; and
 - any other STBG-eligible project, if the Secretary certifies that the State has demonstrated a reduction in transportation emissions, as estimated on a per capita and per unit of economic

- Staff issued a Call for Projects for CRP on December 13, 2023, and a reminder email was sent on January 24, 2024.
- We received one application from City of Gonzales and anticipate fresh applications from City of Central, BREC/EBR combine etc.
- o Key Dates:
 - **December 13:** First Notification for Call for Projects (CRP)
 - January 30: Deadline to Request Assistance for Required Emissions Analysis
 - February 10: Deadline to Request Technical Assistance from BR MPO Staff

Micro-transit and Vanpool Feasibility Study

- During the last quarter of the year (2023) the Commuter Krewe team participated in community events to conduct surveys. Each parish identified in the data analysis (Ascension, East Baton Rouge, Livingston and West Baton Rouge) were included.
- To assist in promoting the survey, we also gained permission from DOTD planning to boost the survey posts on our social media channels (Facebook, Instagram, Twitter, and LinkedIn).
- The result of the entire 3-month effort was 2415 responses. The internal team has reviewed the data and has begun drafting a version of the feasibility study. We are incorporating discussions with CATS into our efforts.
- By the end of February 2024, the draft should be complete, and the team will provide our stakeholders with a one-week comment period and the public with a one-week comment period.
- All feedback will be considered as the goal will be to have the study completed in the 4th quarter.
- Draft Micro-transit/Vanpool Study is complete.
- Final approval will be decided upon by the TAC/TPC (June 19, 2024) and implementation of projects to follow.

Miscellaneous

 Motorist Assistance Patrol (MAP): members were advised that the current MAP contract is up for renewal. Cost projections indicate a possibly forty per-cent (40%) increase.

There followed general discussion regarding the boundaries established for MAP. They currently end in Walker and pick up again in Hammond. There is a need for the inclusion of the area from Walker to Hammond due to the heavy commuter traffic in that area. Members requested that CRPC obtain the data for incidents, times and congestion for the last five (5) years. It was further requested that CRPC write a letter to DOTD requesting them to reconsider providing coverage for the area from Walker to Hammond and request maps, data and the costs involved to provide coverage in this area.
