

## Project # H.013755: I-10: Nicholson - Acadian R/W Acquisition

**Project Sponsor: LADOTD** 

**Reason for Amendment:** Addition of new project/project phases



# **Project Background**

LADOTD is currently in the conducting Environmental Assessment of the I-10 (MS Bridge – I-10/I-12 Split) widening project. As part of this project, DOTD is planning to proceed with advanced Right-of-Way acquisition between Nicholson and Acadian. DOTD expects to complete the Environmental Assessment (EA) by early/mid-summer 2019. The construction of this project is funded through utilization of GARVEE bonds.

#### **Amendment Details**

**Amendment:** Add R/W phase in federal fiscal year 2019.

Cost: \$6.5 Million


Funding Source: National Highway Performance Program (NHPP)

# Project # H.013387: I-10: Grade Raising on Valley Street

**Project Sponsor: LADOTD** 

**Reason for Amendment:** Addition of new project/project phases



# **Project Background**

This is also part of the I-10BR project. The project scope of work includes raising and widening the KCS Railroad Bridge over Acadian Thruway between Perkins Road and I-10, raising the KCS railroad between I-10 and College Drive and raising the grade of Valley Street between Perkins Road and Dawson Creek Bridge. The ROW phase includes the cost for the KCS Bridge in which KCS will LET.

#### **Amendment Details**

**Amendment:** Add Engineering and R/W phases to be advanced constructed in federal fiscal year 2019 and Construction phase in FY 2020

**Cost:** \$7.35M

Engineering - \$500K GARVEE and \$150K Non Federal Aid (NFA)



# Project # H.011825: Buddy Ellis Road Improvements

**Project Sponsor: Livingston Parish** 

**Reason for Amendment:** Carry over project form previous TIP



## **Project Background**

Buddy Ellis is classified as major urban collector, runs east-west and serves as the main connection between Juban Rd (LA 1026) and LA 447. This project was selected by the TPC during 2014 MPO call for projects. It was programmed in the previous TIP (2015 - 2018) for federal authorization in FY 2018. Unfortunately this was not ready for authorization and needs to be carried over in to the new TIP (2019 - 2022). As per the new TIP modification procedures, carrying over a project from old to new TIP is considered a TIP amendment and requires TPC approval.

Amendment: Add Construction phase in FY 2019

Cost: \$3.495M



# **Project Sponsor: East Baton Rouge Parish**

# **Project Background**

This project is phase 2 of Dijon Drive extension and completes the connection between Essen Lane and Bluebonnet Blvd. Phase 1 connecting Essen Lane to the new OLOL children's hospital is under construction currently. It was programmed in the previous TIP (2015 - 2018) for federal authorization in FY 2018. Unfortunately this was not ready for authorization and needs to be carried over in to the new TIP (2019 - 2022). As per the new TIP modification procedures, carrying over a project from old to new TIP is considered a TIP amendment and requires TPC approval.

Amendment: Add R/W phase in FY 2019

Cost: \$3M



Benton Road is classified as urban minor collector, runs north-south and connecting River Road and US 190 in Denham Springs. This project was selected by the TPC during 2017 MPO call for projects. Comments from DOTD stage o review were all addressed. Stage o for this project has been approved and a project number has been assigned. This project was shown in the previous TIP (2015 - 2018) for informational purposes and now it becomes an official project as a number has been assigned. This is considered as addition of new project to the TIP and requires TPC approval.

# **Project Background**

Germany Rd is classified as urban collector, runs east-west and connecting US 61 and LA 44 in Ascension Parish. This project was selected by the TPC during 2017 MPO call for projects. Comments from DOTD stage 0 review were all addressed. Stage 0 for this project has been approved and a project number has been assigned. This project was shown in the previous TIP (2015 - 2018) for informational purposes and now it becomes an official project as a number has been assigned. This is considered as addition of new project to the TIP and requires TPC approval.

**Cost:** \$5.1M



# Project # H.013797: LA 30 Widening (Brightside – Airline)

**Project Sponsor: CRMPO (Regional Project)** 

**Reason for Amendment:** Project number assigned – addition of a new project phase



# **Project Background**

LA 30 is classified as principal arterial, runs parallel to I-10 through Ascension, Iberville, and East Baton Rouge Parishes. This project was selected by the TPC as a regional project during 2017 MPO call for projects. The purpose of the project is to look at the various options for improving current and future traffic flow on LA 30 corridor. This will also be critical link for getting traffic to a future new South Bridge. The funds allocated are for completing the Environmental Assessment for the entire corridor. DOTD assigned a project number for this during last quarter of 2018. This project was shown in the previous TIP (2015 - 2018) for informational purposes and now it becomes an official project as a number has been assigned. This is considered as addition of new project to the TIP and requires TPC approval.
